Endowment is a vital funding source for The Denver Public Library's long-term financial health. The Endowment consists of several restricted endowments and an unrestricted endowment. The restricted funds support a broad array of programs/services/materials within The Denver Public Library, while distributions from the unrestricted endowment are prioritized for specific current needs as requested by the Library and approved by the DPLFF Board of Trustees. Restricted endowments in 2014 supported acquisition of a variety of titles for the circulating collection. Examples include materials relating to post-secondary education and GED preparation, musical scores and poetry anthologies. A restricted endowment for staff training/development purchased training

materials. Endowments relating to Western History/Genealogy provided for
 acquisition of antiquarian materials and supported the preservation and
