The 40% increase in hours afforded by the initiative brought an increased demand for programs, services, and materials. The Denver Public Library Friends Foundation (DPLFF) continues to be committed to providing increased funding to meet those needs. Grants from DPLFF to the Denver Public Library during 2013 provided funds for books and other materials for a broad spectrum of community interests.
