Funds supported Central Library Renovations, the Western History and Genealogy Department, Collection Development, and maintenance at branches. Foundation grants supported programs that foster a life-long love of reading in children including "Summer of Reading" and "Read Aloud." Funds were used for programs supporting new immigrants and refugees, including citizenship classes and targeted programs to improve English language skills. Foundation grants also supported DPL's services for older adults, people experiencing
